3) Approval and ratification of MOM – GBM 2023 at Hotel Sheraton Grand on 17<sup>th</sup> June 2023

Minutes of Meeting was circulated on email to all members and same was read by Dr. Khandalkar.

Dr. Gautam Salaunkhe said, regarding the minutes of last GBM and issues about the constitution amendments I have some observations. Last time we discussed some points on constitution amendments and when we came back in GBM at POSAC we couldn't see them on website and they were not on the screen so I objected to that and then they came on the website. Now my main issue which we have discussed was that in case disciplinary action to be taken against member when a member goes to court against committee there is a clause if the members looses in court he will be terminated and if he wants to come back he need to bear all the expenses incurred by the association. But if he won the case he will be taken back, where I raise the point that, if he need to pay the court expenditure to association when he loses, but if he wins, association also pay him the compensation which was agreed. Now on website it is written that if member wins he need not have to pay court expenditure rather he should be given legitimate expenditure for the court case and if member loses he should pay all the expenditure incurred by the association. Here the expenses to be paid to member in case he wins is not clearly mention and who will pay it is also not mentioned.

- Dr. Chetan Pradhan replied, in that GBM it is concluded that the legal expenses which is involve with that court case either party whoever wins. Dr. Gautam Salunke, the things are not clearly mentioned in constitution, who will pay, how much will pay, legal expenses means etc.
- Dr. Swapnil Bhise replied we can work on this what Gautam sir observations are can be taken in next EC meeting and according will take it to next GBM.
- Dr. Gautam Salunkhe, I am sending my observations in constitution since March 2022, there are some grey areas I have submitted 8-9 points from 2-3 are come to discussion always I got replied in GBM not have enough time and all etc.
- Dr. Khandalkar replied, sir all points were well discussed and you was given enough time.
- Dr. Chetan Pradhan suggested Dr. Gautam Salunkhe to send your observation one more time to POS office on official email, it will be taken in EC meeting and same can be put it before GBM. The issues which I can understand from you can be changed.
- Dr. Swapnil Bhise suggested, we can have a separate discussion on this amendments, once Dr. Gautam Salunkhe send mail to POS office we can invite him for discussion in one of the EC meeting were we can modify or change the amendments required.

Dr. Gautam Salunkhe replied, same thing I was expecting since long time when I sent an email in 2022, we would have seat, discussed and sorted out these things.

Dr. Goverdhan Ingale said, the points raised by Dr. Gautam Salunkhe was discussed in 2022 GBM but still I feel there are some points which he raised are pending so I suggest that the current EC senior members can seat and discuss with Dr. Gautam Salunkhe and required changes can be done.
