Dr. Arjun Viegas welcome all the present members & because of lack of quorum, GBM was adjourned for till 07:35 pm.

Dr. Arjun Viegas welcome all the present members and now quorum was not required. As Dr. Yogesh Khandalkar was engage to see off Dr. Bhosale chief Guest for POSAC 2024, Dr. Arjun Viegas as President continued to conduct the meeting.

Dr. Arjun Viegas welcome all the members, and started the proceeding as per agenda.

4) To confirm the Minutes of last AGBM conducted on Saturday, 07th October 2023 at Hotel President, Pune

Minutes of Meeting was circulated on email to all members and same was displayed on screen by Dr. Arjun Viegas.

Dr. Gautam Salunkhe said, in minutes Dr. Khandalkar said I was given enough time to discuss and on otherside Dr. Chetan Pradhan, Dr. Bhise, Dr. Ingale said things need to be discussed with me and it was agreed. So I want to know that how the minutes stat that I was given enough time. Further this meeting is recorded and many things are not minuted for e.g. Dr. Pradhan said this issue of the constitution amendments we shall seat, discuss & finish in time bound manner.

Dr. Gautam Salunkhe took objection on writing of the minutes, he gave an example of Pune Cantonment Board and Surgical Society & Association of Medical Consultants in Pune where they use to write the minutes in 1 month and circulate to the members. Our President & Secretary use to write the minutes after the announcement of meeting after the 5 months down the line when everyone forgotten and nobody is interested. He objected on writing of minutes. Now about the constitution issue I am greatful to Dr. Viegas, Dr. Khandalkar, Dr. Pradhan and others who took this issue seriously and we wanted to discuss it in time bound manner, so have we discussed it?

Dr. Arjun Viegas replied, the constitution issue was discussed in two meetings from that you were also invited for one of the meeting.

Dr. Gautam Salunkhe raised the objection that this meeting minuted were not available

Dr. Yogesh Khandalkar replied, you were invited as a special guest and we discussed the issue after the President adjourned the EC Meeting. As all the EC members are easily available at the time of EC meeting hence you were also invited on same day. So as the things were discussed after the adjournment of EC meeting the minutes are not on website.

Dr. Arjun Viegas suggested to have a separate meeting with Legal cell along with Dr. Salunkhe, Dr. Karne, New President Secretary, Past President Secretary and amicably solve this issue.

Dr. Gautam Salunkhe raised an objection after the six weeks I called you and then I was invited for meeting and now you don't want to minutes it saying it was called for discussion.

Dr. Khandalkar & Dr. Arjun Viegas called President Elect Dr. Gowerdhan Ingale & Dr. Secretary Elect Dr. Shailesh Hadgaonkar on dais.

Dr. Chetan Pradhan suggested, this issue of constitution amendments is lingering from last 3 years and same will be continued if this will go like this. We need to set the time bound, seat together new office bearers, Dr. Karne, Board of Trustees and an advocate and get the matter resolved.

Dr. Gautam Salunkhe said, if Trustees decisions are not binding on EC then what's point of taking them. Even about the advocate it's not necessary to involve him, we can take the decision and inform him.

Dr. Chetan Pradhan told that this topic should not be in the next GBM, whatever kindly resolved it amicably.

Dr. Karne said, about the things are not minuted in EC meeting, actually the official EC meeting is different were all the EC members comes. But as just Dr.

Chetan Pradhan said we can go one step ahead and show more approach which can be formal meeting. So it was the mutual discussion where all the EC members and Trustees were present. The same issues were discussed in two consecutive GBM and decision were taken but still if some respectable member has some grievances that can be solved amicably with the discussion. But that's was not an official meeting, once the meeting was called end that the end of the official meeting further discussion was there as most of the EC members were there and that's why it is not came in the minutes. The minutes are the official record of the meeting which we need for Charity Commissioner.

Now second about the involving Advocate, advocate is the one who give us the advice in the Charity Commissioner court but the discussion about the terms or with the constitution is with us. What is the General body – It is the group of people who come together and form an association on certain term and condition and rules and regulations that is called as constitution. So that is decided by the General Body and not by advocate. Something going grossly wrong which affects the fundamental rights of the members then we can have the opinion of advocate. So among the GB whatever the grievances of the person can be solved with the majority. If the majority feels 'X' person is saying is correct and even if it is not acceptable to few it is taken. All this discussion was done in two previous GBM's and decision were taken, repairs was done and they were approved by the GB. But same issue comes again and again it is the waste of time of GB. Now about the 3rd GB where this issue is coming, it can be discussed with the permission of chair and decision can be taken here by GB. Because even if we call the meeting for amicable decision that can't be the official. Let the GB take the decision here and that same issue will not come again and again.

Dr. Gautam Salunkhe said according to Dr. Karne whatever points I have raised you should discuss in GB I had submitted the whole list. Second thing is writing of the minutes, things happened are not in the minutes. It is not that everything be unanimous there can be dissonant.

Dr. Karne told why there is approval required for the Minutes of the meeting, the discussion done in the GBM that need to be written in minutes and then that has to be approved by the next GB so the opportunity is given to all the members who were present or not present to find out because minutes of the meeting is the legal document. If some member is not happy with the minutes and has some corrections, then it can be verified and done. Fortunately, we have started video recording since last three years so it can be verified. So something missing in the minutes of the meeting is not the crime it can be corrected after verification and approved by majority but once approved it should be taken as approved by majority.

Dr. Gautam Salunkhe replied your standard method is to write the minutes 5 month later and get the approval of GB and I think this unfair method.

Dr. Karne replied, you can give the minutes of the meeting to members 15 days before of next meeting and not immediately. 15 days' time is given to the members to see and verify the minutes.

Dr. Gautam Salunkhe said meeting happened 5 months before

Dr. Karne replied 5 months 10 months that is not an obligation, they should give before the next meeting.

Dr. Gautam Salunkhe said I had already given an example of how the minutes are written in other societies. If you choose this is not obligatory, we have to write it 5 months later that's upto you, you can take a decision by majority, you know that hardly anybody comes hardly anybody remembers. Do you produce the video recording? What is the reason behind this, I am telling you this is the way to just sideline the issues. And you want to sideline the issue this is irrelevant you tell me straight, I am not doing it for myself. I have nothing to gain in that but what I read over there and what plain English I can understand I am trying to tell you people. And if you don't have time don't write in the minutes that you was given enough time.

Dr. Karne asked Hon. President that have you refused to provide the video recording to Dr. Gautam Salunkhe?

Dr. Arjun Viegas & Dr. Yogesh Khandalkar replied, they had not refused to give recording.

Dr. Karne told that if a member demanded a video recording of meeting it can be given to any member after taking certain charges against it. A member can go through the recording and send us that this was there and it is not minuted so that can be corrected. Off course Chairman has certain rights to delete recoding if he feels its objectionable. But if the member put this before the GB and GB approve it to be minuted then that should be minuted.

Dr. Gautam Salunkhe told it happened in the same meeting if you would have told me recording it will be provided to you later it was ok.

Dr. Arjun Viegas said, lets rest the previous meetings, we will organize the new meeting at the earliest within one week.

Dr. Gautam Salunkhe said, I would request you please be serious about this because setting a President what happening in another association I know I can read through the whole thing. If you are interested, if you are serious, Okay. I will put those things, if you don't have the time ok fine but you come up and say that I was given enough time.

Dr. J M Talesara suggested to organize a meeting within 1 month.

Dr. Arjun Viegas replied, ok 1 month but it will not be part of the EC meeting, it will be separate meeting.

Dr. Gautam Salunkhe asked are you going to minute it?

Dr.Karne told, what Hon. President is suggesting is good for amicably solving things but it will not be a legal meeting. Legally no parliament called for one person and ask in front of them. You are doing it in favor of allegiant who had alleged.

Dr. Gautam Salunkhe replied, I don't want any favor.

Dr. Karne told, what I trying to say that EC meeting has an agenda and need to follow all protocols, so don't term as an EC meeting, you can call as informal meeting, unofficial meeting where you are trying to resolve some issues

amicably. Further I will suggest that, let the concern person give the list of grievances, then let that given to everybody because right now in the meeting we cannot take the decision unless we go through all this issues. You ask the member to send his grievances to POS office the you send it to all members ask to go through the constitution. Even you can also give reply to that member on his grievances and if he doesn't agree to that then put the same in front of GB and let the GB decide on it and once the GB give its decision it's over. So if you are calling the meeting, it's not an official meeting.

Dr. Gautam Salunkhe replied, so it's not an official meeting, and concern member have submitted you 2 or 3 times on mail and if you don't know it is not my fault. So again I am asking you are you serious about this? If you say send it again I will send it again.

Dr. Yogesh Khandalkar replied, definitely forum is serious about it and we will take an action on it.

Dr. Arjun Viegas replied, we will resolve this matter within a month.

Dr. Gautam Salunkhe said, thank you to Dr. Arjun Viegas, I am banking on your word.

Dr. Talesara raised the question are you going to call EC meeting or it will not be recorded?

Dr. Karne said, are you going to call the meeting or ask for letter, whatever you want to discuss more than the letter then you need to call extra ordinary general body meeting for that.

Dr. Chetan Pradhan said, then why not to call official meeting because again if it will unofficial meeting it will not have meaning. So let's call official meeting.

Dr. Karne told for an official meeting the member should know about the grievances and what is there in the constitution. So for that I suggested send the grievances letter and constitution to all members let all members go through it. And EC will also give their reply on grievances and if the member doesn't agree to the EC reply then that should be put to GB calling Extra Ordinary General Body. Dr. Kiran Kharat said, I talking on behalf of the members present here who are confused as to what's going on. Let me try to summaries what I can understand, so there is a constitution which all of us respect, there were some amendments proposed and in 2022 GBM at Sheraton I stood up, as Dr. Gautam was not present, on his behalf I read out some points, which was to be addressed and I was assured the bench of that time that it will be addressed. It was also an official GB and was minuted officially. And now in this official GB Dr. Chetan Pradhan is saying that this should be addressed very systematically without any confusion. Dr. Chetan Pradhan said, before this two GBM happens 2022 and 2023 but Dr. Salunkhe's objections did not reach any logical conclusion, they could not be resolved which satisfies him. I feel rather that spending time in every GBM, see what Dr. Gautam saying is also right his grievances are not getting resolved any of the GBM official, unofficial or anyway. So somewhere we need to call a day

and that's need to be an official. Also I suggest as GB we gave consensus that we

give the next EC and the office bearers authority to resolve this issue once for all by taking a special meeting.

Dr. Sachin Nagapurkar said, majority of the members of POS don't know the issue so I suggest to send the objections raised by Dr. Gautam Salukhe to all members by email to go through the same and give 15 day's time and after then you can call meeting.

Dr. Gautam Salunkhe said, I had send the objections twice or thrice to office if they don't send it to members or read before the members is not my fault.

Dr. Chetan Pradhan said, Dr. Gautam we will redo this all exercise again to put an end to this issue.

Dr. Karne suggested, let the Dr. Gautam Salunkhe send his objections again to the POS office and then POS office will send it to all the members along with the constitution giving 15 days' time to respond with their suggestions. And after that the received suggestions and POS EC reply will be send to Dr. Gautam and if he still not satisfied with it then President can call Extra Ordinary General Body Meeting.

Dr. Talesara told that, very few people read this email and respond then how can you take the decision.

Dr. Karne told every member has given this platform of GB to express their suggestions, objections, grievances and if they are not attending it's their fault otherwise this will go on for years.

Dr. Gowerdhan Ingale suggested to have a committee of last 3 years' office bearers, Dr. Gautam Salunkhe and other interested members

Dr. Karne told its unlawful solutions, if this will go in the court things will go against POS. You have to go according to the law rules and regulations. The situation is already discussed in GB no persons or group of person can solve that, it is addressed in GB so GB has the rights to know his grievances. Only I am trying to tell that this will not resolve in single meeting. Member should go through the grievances as well as constitution, they need to ready it study it. Let everybody has the full knowledge about the constitution and grievances.

Dr. Chetan Pradhan said, it seems that there should be Extra Ordinary General Body Meeting for this issue. Actually if this GB gives the authority to coming EC to resolve this issue after circulating Dr. Gautam Saluknhe Objections and POS constitution then there will not be a need of Extra Ordinary General Body Meeting.

Dr. Arjun Viegas replied, even if call the Extra Ordinary General Body Meeting we have experienced very poor attendance, we need to generate interest in this issue. I personally take interest in this matter I promise this matter will be resolve, we will call the Extra Ordinary General Body Meeting also we will ensure that there will adequate quorum. For now, let's rest this matter here, we will see that it will get it resolved at earliest.

Dr. Gautam salunkhe told to write the minutes properly.

Dr. Yogesh Khandalkar and Dr. Arjun Viegas relied, today's meeting is recorded.

Dr. Karne raised the strong objection alleging the office bearers that you are not writing the minutes properly. You are given chance to speak what is not their but you cannot allege them. To order them or to allege them is a derogatory word which I strongly object.

Dr. Gautam Salunkhe told It is written in the minutes that I was given enough time which I object.

Dr. Karne proposed the resolution that Dr. Gautam Salunkhe has send certain grievances in past certain emails in the past but that emails were not addressed according to him. Dr. Gautam will write an email again to POS office.

Dr. Arjun Viegas said, sir we will accept his previous emails.

Dr. Karne told he has send 2 or 3 emails which you are going to accept.

Dr. Gautam Salunkhe told the same letter is repeated again you want to repeat it I will send it every day.

Dr. Karne asked Dr. Gautam – How many letters you have send sir?

Dr. Gautam Salunkhe replied – 3 and all are same

Dr. Karne said, as it is very important you have to specify email no. 1, email no 2. Or email no 3.

Dr. Talesara said all letter are same

Dr. Karne told let Dr. Gautam tell about it.

Dr. Gautam Salunkhe said, everything is my responsibility

Dr. Jagdeesh Panse said, Karne sir our president has given a ruling he has close this chapter and he said go to the next point and again you are raising the same point. I object once the president has given ruling you have no right to talk.

Dr. Karne said resolution should be in the proper words and someone need to propose it, someone need to second it and then it has to be put on the voting and then it is approved. This is the modus operation of ideal resolution. I am not challenging President as Dr. Panse sir said. Resolution can be put by any member. I have right to put the resolution and no one can stop me with my rights.

Dr. Karne proposed a resolution, our honorable member Dr. Gautam Salunkhe has send grievances by emails in the past, those were discussed in previous two Genaral body Meetings and some EC meetings also but those are not yet resolved. So we request Dr. Gautam Salunkhe to send the specific email of his grievances to POS office and then POS office will send the letter of Dr. Gautam Salunkhe grievances along with POS Constitution to all POS members on emails with 15 days' time to respond with their opinions or suggestions. After 15 days the responses received to POS office will be informed to Dr. Gautam Salunkhe and if still it not resolved then will call Extra Ordinary General Body Meeting. Seconded by Dr. Chetan Pradhan and Dr. Jagdeesh Panse, approved unanimously *(Resolution No. 01/GBM/08 June 24)*

Dr. Gautam Saluknhe told I will resend the letter with mentioning all previous communication.

Minutes of Meeting dated 07th October 2023 were approved unanimously excepting Dr. Gautam Salunkhe objection on Secretary said that enough time was given to him.
